(All paperwork and money must be in the district office by this date)

Students, chaperones and delegates **\$600.00** (includes airfare)

Delegates with no airfare - **\$450.00**

Registration Includes:

- Registration and Information Packet
- Embassy Suites Hotel with internet access (2 nights); 100 Capitol Mall, Sacramento. Students will be housed with 2 or 3. Adults will be housed with 2 unless single room is requested (additional \$210.00)
- 2 dinners, 2 breakfasts and 3 lunches
- Taxes, tips and hotel portage
- Students, chaperones and adult delegates - round-trip air transportation (adult delegates may choose to not travel with the group)
- Students, chaperones and delegates - buses between airport and hotel (delegates traveling separately must make arrangements to and from the hotel – hotel offers a shuttle)

Program Includes:

- Two mandatory orientations for all attending Sacramento Safari:
Wed., February 15, 2012 & Mon., March 12, 2012. The mandatory orientations will be held at 7:00 p.m. in the El Segundo High School Library, 640 Main St., El Segundo
- Extraordinary speakers
- Meetings with **your** legislators
- Legislative committee meetings
- General Sessions of the Senate and Assembly
- Guided tour of the Capitol
- Meetings with PTA advocates

Each unit or council sending a HIGH SCHOOL STUDENT must provide a chaperone. Thirty-Third District PTA will provide a certificated teacher as part of the program.

Group Air Flights:

Depart Sacramento on Tuesday, March 20th at 6:50 p.m.

Picture ID is required by airlines. It must match the name on the ticket.

Airline tickets for chaperones and students will be distributed at the second mandatory orientation.

Reservations and checks must arrive at the Thirty-Third District PTA office no later than January 10, 2012.

No reservation is confirmed until full payment and reservation forms are received and eligibility is checked. Safari may be sold out – each form will be date stamped to determine priority.

There will be **no refunds**. Substitutions may be allowed prior to March 1st. Approved substitutions *may be* subject to a 10% late fee, additional airline charges, and any handling and postage fees.
